

# MEMO

**To: ALL CSRDS Dance Leaders & Clubs that hold a Licence issued by Entandem**

**Callers, cuers, instructors, and clubs** - that have existing accounts with Entandem/SOCAN have just received an email from Entandem. In that email you were asked to "*Kindly fill out the attached report form...*" with a hyperlink to a 'fill-able' form.

That form is to "report" the # of dance classes that you held in **2022** & from that #, it calculates the fees for **Re:Sound Tariff 6B for 2022**. (which is # of classes/dances you held X 0.467 as showing on the form.)

**Please take close note of the following points:**

- Complete the top portion of the form & then enter the number of classes you held in 2022 in **PART A ONLY**.
- **DO NOT** put any information in either Part B or Part C **as they do NOT apply** to our dance (squares, rounds, lines) activity!
- The form automatically calculates the fee + applicable taxes.
- As requested, sign & date the form & send it to Entandem. Send the information to [license@entandemlicensing.com](mailto:license@entandemlicensing.com) – DO NOT reply to the e-mail message you got. That message came from a "do not reply" address and replies will not reach Entandem.
- **Entandem states in their email that:** -
  - "*This information will be used to update your 2022 Re:Sound Invoice*". So most likely this will come out to you shortly after you've sent this form in to them.
  - "*You will also soon receive your SOCAN invoice for 2023....*"

**NOW, in order to get the "special" CSRDS SOCAN rate** (as well as the conditions negotiated for both SOCAN & RE:SOUND), **you MUST also do the following:-**

- When you do receive your SOCAN invoice for 2023, **you MUST confirm to Entandem that you are a "CSRDS Leader or Club"** and make reference to "*CSRDS Account #1092388*", otherwise you will NOT get the special SOCAN fee, nor RE:SOUND options that have been negotiated by CSRDS!

In summary then, if you've already received the Entandem email then fill out the form (as described above), submit it to Entandem and BE SURE to identify yourself as a CSRDS member!!

If you haven't got that email yet - you will IF you've already got an account with Entandem.

**DON'T HAVE (or yet have) AN ACCOUNT WITH ENTANDEM?**

Unless the dance club holds a valid Entandem licence, all CSRDS Leaders are required by the Copyright Laws of Canada, to be licensed to play recorded music (e.g.: records, CD's, MP3's etc.) in a public place (e.g.: your dance club hall) – and need to be licensed through Entandem. If you need to hold such a licence, and don't already hold one, then contact Entandem directly and open up an account with them. In doing so & following the guidelines shown above, you will qualify for the 'special' rates being granted to all CSRDS Members.

*FYI, the new agreement between Entandem/SOCAN and CSRDS is VERY close to being signed, so more information will be forthcoming very shortly on that.*
